Introducing DAP - Document Accessibility Profile

- Applicable to ebooks, etextbooks, OER, digital documents
- Leverages existing standards
- Describes accessibility in plain language
- Product information provided by publisher
- A description, not a rating system



Benefits of a DAP ecosystem



- Establishes a level playing field
- Puts the emphasis on consumers
- Publishers can proactively address accessibility issues
- Helps grow confidence in the accessibility of commercial products
- Supports the transition from accessibility by accommodation to born accessible
